



ACHIEVING CARBON NEUTRALITY: SUSTAINABLE BUSINESS MODELS, SOCIAL ENTREPRENEURSHIP AND B CORPS

There is an exponential growth in academic research related to social and environmental sustainability, which responds to the need to reshape capitalism and find new organizational forms and business models to support a sustainability transition. The climate crisis has multiple manifestations; among the most impactful are the temperature increase and the consequent scarcity of resources. To address this crisis, companies need to be able to develop resilience plans and rethink their production and consumption patterns adopting circular models to ensure the efficiency of the resources used.

This second edition of the TRACY workshop focuses on the role of sustainable business model, social entrepreneurship, and B Corps in achieving zero-carbon neutrality, disentangling the factors (e.g., institutional, at the industry and/or firm level) leading firms to meet the net-zero goal.

The workshop focuses on emergent issues related to sustainable development: a development that meets the needs of current generations without compromising those of the future generations. To respond to global changes, it is necessary to embrace a forward-looking approach, oriented to avoid or mitigate negative impacts and to adapt quickly to ongoing changes.

Transitions towards carbon neutrality entail changes in the interaction between individuals and organizations and between them and the environment at the local and global scale. Therefore, we feel the need of expanding the current knowledge base for understanding the micro and meso dynamics of the changes, bridging the boundaries between disciplines, geographies, cultures, and institutions, and between scholars and practitioners.

The contents of the workshop relate, but are not limited, to these themes:

1. Sustainability transitions in the energy sector
2. Inclusive and sustainable global value chain
3. Technological change, innovation networks and sustainable business models
4. Clusters' transition towards sustainability
5. Culture and creative industries in sustainability transitions
6. The role of sustainable certifications, and certified companies, such as the B Corps, to stimulate local/regional/national transformation towards sustainability
7. Place-based sustainable innovation trajectories and policy actions
8. The effects of green strategy adoption on competitive benefits
9. Carbon neutrality and circular economy



We encourage submissions from scholars in the social and scientific sciences, practitioners, innovators, and leaders who are forging ahead with strategies to shift towards sustainability. We welcome contributions that develop innovative approaches in concepts, theory, methods, or analysis and have deep or broad implications to inform transitions to environmental sustainability, and that use observational, experimental, or theory-driven modes of inquiry.

Extended abstracts should contain a minimum of 500 words and a maximum of 2500 words. Extended abstracts can contain figures, tables and/or images, which are not included in the word count. **Full papers (optional)** should not exceed 8000 words, inclusive of the abstract (150 words), tables, references, figure captions, and endnotes.

The acceptance of the extended abstracts/full papers shall be announced by **November 20th, 2022**.

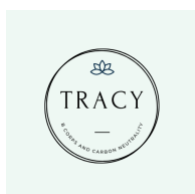
